This report contains a list of titles reviewed by the Prohibited Importations Unit (PIU), Border and Compliance Programs Directorate, at Headquarters in Ottawa, during the period **January 1 to March 31, 2005**. All titles for which a determination was rendered in accordance with section 58 of the *Customs Act*, or re-determined as per sections 59 and 60 of the *Customs Act*, during the stated period are listed, along with the related decision. Titles are categorized by commodity and listed alphabetically. Where available, additional bibliographical information has been included.

You will note that the report has been divided into three sections:

**1) Section 58 – Determinations:** This section lists titles for which initial classification decisions have been made at Headquarters in accordance with section 58 of the *Customs Act*. Goods are “determined” to either fall within or outside of the provisions of tariff item 9899.00.00 (obscenity, hate propaganda or child pornography).

**2) Section 59 – Re-determinations:** This section lists titles that have been previously prohibited under tariff item 9899.00.00 and which have been the subject of program monitoring. The re-determination was initiated by the PIU, in order to ensure that goods have been correctly classified.

Le rapport ci-joint contient une liste des titres examinés par l'Unité des importations prohibées (l'UIP), Direction des programmes de l'observation et de la frontière, à l'Administration centrale à Ottawa, entre le **1<sup>er</sup> janvier et le 31 mars 2005**. Tous les titres pour lesquels une décision a été rendue conformément à l'article 58 de la *Loi sur les douanes* ou pour lesquels une révision a été faite conformément aux articles 59 et 60 de la *Loi sur les douanes*, durant la période en question, sont indiqués, ainsi que la décision connexe. Les titres sont séparés selon le genre de matériel dont il s'agit et présentés par ordre alphabétique (le tout selon l'anglais). Des renseignements bibliographiques supplémentaires ont été inclus lorsqu'ils étaient disponibles.

Vous constaterez que le rapport est divisé en trois sections :

**1) Article 58 – Déterminations :** Cette section présente la liste des titres pour lesquels une décision de classement initiale a été rendue par l'Administration centrale, conformément à l'article 58 de la *Loi sur les douanes*. Il est «déterminé» que les biens sont visés ou non par les dispositions du numéro tarifaire 9899.00.00 (obscénité, propagande haineuse ou pornographie juvénile).

**2) Article 59 – Révisions :** Cette section présente la liste des titres préalablement prohibés en vertu des dispositions du numéro tarifaire 9899.00.00 et pour lesquels une révision a été effectuée. La révision a été amorcée par l'UIP dans le cadre du contrôle de programme, en vue de confirmer la validité du classement tarifaire.

**3) Section 60 – Re-determinations:** This section lists titles that were previously prohibited under tariff item 9899.00.00 and which have been re-determined, at the importer’s request, by the Customs Disputes Section, as per section 60 of the *Customs Act*.

**3) Article 60 – Révisions :** Cette section présente la liste des titres préalablement prohibés en vertu des dispositions du numéro tarifaire 9899.00.00 et pour lesquels une révision a été effectuée, à la demande de l’importateur, par la Section des différends douaniers, conformément à l’article 60 de la *Loi sur les douanes*.

For the purposes of this report, decisions are defined as follows:

**1) Prohibited:** This indicates that the material was reviewed and found to fall within the provisions of tariff item 9899.00.00. Its importation into Canada is therefore prohibited, i.e. not allowed, as it constitutes obscenity, hate propaganda or child pornography.

**2) Admissible:** This indicates that the material was reviewed and found NOT to fall within the provisions of tariff item 9899.00.00. Its importation into Canada is therefore acceptable, as it does not constitute obscenity, hate propaganda or child pornography.

This list should only be consulted as a reference guide and should not be considered an absolute authority. **1) Prohibé (*prohibited*) :** Ce terme indique que, par suite d'un examen, il a été établi que le matériel est visé par les dispositions du numéro tarifaire 9899.00.00. Son importation au Canada est donc prohibée, c'est-à-dire qu'elle n'est pas permise, car le matériel constitue de l'obscénité, de la propagande haineuse ou de la pornographie juvénile.

**2) Admissible :** Ce terme indique que, par suite d'un examen, il a été établi que le matériel n'est PAS visé par les dispositions du numéro tarifaire 9899.00.00. Son importation au Canada est donc acceptable, c'est-à-dire permise, car le matériel ne constitue pas de l'obscénité, de la propagande haineuse ni de la pornographie juvénile.

Cette liste devrait être consultée à titre de référence seulement et ne devrait pas être considérée comme constituant une autorité irrévocable.
